This form allows you to ask Afnic, in its capacity as delegate of the .museum gTLD for MUSE DOMA INTERNATIONAL (MDI), Registry for same, to proceed with the disclosure of the personal data of an individual registrant of a domain name recorded under the .museum gTLD and who has opted for their credentials to be restricted information.

Afnic analyzes your request as soon as possible, based on the grounds given in the supporting documents provided in French or English.

The disclosure of personal data can be obtained in the case of reproduction in identical or quasi-identical form:

- of a currently valid prior industrial or intellectual property right:
 - of a trademark;
 - of the title of a work protected by authors' royalties or copyright;
- of a distinguishing feature registered earlier (corporate name, business name, trade name, banner brand, domain name)
- a surname or pseudonym.

Afnic's analysis focuses in particular on the similarity of the signs and does not concern the content of the sites.

Requests for the disclosure of personal data must come from the owner of the rights invoked (copy of the identity document for a natural person, company registration certificate (K-bis) or INSEE identification form for a legal person, etc.) or must be accompanied by a power should the applicant not be the owner of the rights.

In case of refusal, you will have recourse to the other procedures foreseen by the [.museum registration policy](#).

3. Reasons for the request

Please accompany your request with the reasons for the latter, being as precise as possible, and attach documents to identify you (commercial registry (K-bis) form, INSEE database extract, declaration of association, identity card etc.) as well as any document justifying your rights. Afnic responds to your request with regard to the documents sent to it and does not perform any further research.

4. Applicant's commitments

If the Afnic agrees to your request, the data that will be transmitted to you are personal within the meaning of the legal framework relating to the protection of personal data. As such, they will be transmitted to you in strict confidentiality.

You undertake:

- Not to use the data for reasons other than those specified in this form (and/or any annexes).
- To maintain the confidentiality of the personal data transmitted and not disclose it to third parties except for the benefit of duly authorized persons residing in countries offering an adequate level of personal data protection.

When Afnic agrees to your request, the personal data relating to the holder of the domain name concerned will be sent to you by e-mail, which is itself protected by the confidentiality of correspondence.

The information transmitted by Afnic corresponds to the information entered by the Registrar at the time of the request to register the domain name(s) in question. The applicant also undertakes not to hold MDI and/or Afnic liable for the personal data transmitted.

5. Information on the processing of your personal data & the exercise of your personal rights

The information that must be provided is marked with an asterisk. Should the information marked with an asterisk not be provided, your request cannot be taken into account.

The information collected is subject to computer processing by MDI and Afnic, as joint controllers of the processing to allow them to analyze the request for disclosure of personal data sent to them in accordance with the Registration Policy for domain names registered under the .museum gTLD and to generate statistics. This processing of personal data is necessary for the fulfilment of the contract formed with MDI via this form.

The recipients of the data are the authorized services of Afnic and MDI.

Your identification data as well as the exchanges and documents relating to the management of your request are destroyed six months after the last exchange.

You have personal rights, namely the right to access, oppose, rectify and delete data, the right to limit the processing thereof, the right to lodge a complaint with a supervisory authority and the right to define guidelines for the retention, deletion and disclosure of your personal data in case of death; your personal rights may be exercised by contacting the Afnic legal affairs department at juridique@afnic.fr.
